

## Equine Network Official Contest Rules

1. Introduction: Equine Network, LLC (d/b/a USRider (“Sponsor”) is offering the USRider Giveaway (“Contest”). NO PURCHASE NECESSARY. A PURCHASE DOES NOT IMPROVE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED.

2. Eligibility: Entrant must be eighteen (18) years of age or older as of April 1, 2026 (or age of majority in state of residence) and a resident of the fifty (50) United States and the District of Columbia. Employees of Sponsor or Prize Provider, immediate family (defined as parents, spouse, children, siblings, grandparents) of each such employees, subsidiaries, affiliated companies, agents and all those with whom such employees are domiciled are NOT eligible.

3. Timing: Contest begins at 12:00:01 a.m. E.S.T. on May 1, 2026 and ends at 11:59:59 p.m. E.S.T. on May 24, 2026.

Contestants may enter once (1 time per person) during the Contest period. More than one (1) entry from any person or email address during the Contest period will void all entries from that person or email address. Sponsor is not responsible for late or incomplete entries. If a problem occurs in the online submission process, Entrant should receive an “Error” message. However, the responsibility to electronically complete the Entry process is the Entrant’s and neither the Sponsor nor the Contest Administrator shall be responsible for any entry not actually received due to incomplete or improper transmission. Similarly, neither the Sponsor nor Contest Administrator has any obligation to advise Entrant of an incomplete Entry or submission.

This contest will have one winner randomly selected and contacted by email or phone. No purchase necessary to enter. By entering your email address, you agree
